Upon receipt of payment, cards will be shipped to the site address above for distribution by your fundraising participants.

I request to distribute my own cards and if I choose to have Click Club USA distribute the cards, I must provide a copy of filled card orders and I understand that Click Club USA will deduct \$2.00 per card for postage and handling.

Click Club USA will provide my organization with order forms to assist me in organizing a successful fundraising campaign for no additional charge. There is no obligation to order any specified quantity of membership cards. I also understand that our organization will automatically receive any future membership dollars from any renewed cards.

IMPORTANT NOTE: Please remind your participants soliciting cards to qualify the potential card member recipient and remind them that they **must have access to the Internet to attain the Click Club USA offers**.
